Subject: Revised procedure for students to file online Anti Ragging Affidavit.

Dear Madam/Sir,

As you are aware, in pursuance to the Judgment of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and in compliance of the 2nd Amendment in UGC Regulations, it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year at either of the two designated web sites, namely, www.antiragging.in and www.amanmovement.org.

As part of UGC's initiative towards reduction of compliance burden of its stakeholders, UGC has revised the procedure for students to file online Anti Ragging Affidavit.

The revised procedure is as follows:

Step 1: A student will submit his/her details on the same web sites (www.antiragging.in and www.amanmovement.org) as before; read and confirm that he/she and his/her parents/Guardians have read and understood the regulations on curbing the menace of ragging. He/She will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).

Step 2: The student will receive an E MAIL with his/her registration number and a web link. The student will forward the link to the E mail of the Nodal officer in his/her university/college. **(Please note that the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be the case earlier).**

Step 3: The Nodal Officer in the university/college can click on the link of any forwarded e mails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his/her college. The list will be updated every 24 hours.

ANTI - RAGGING POLICY

The anti-ragging policy adopted by the institution takes care of curbing the menace of Ragging in Higher Education Institution based on the Guidelines provided by the UGC and Chaudhary Charan Singh University, Meerut. As per the policy, the college shall:

- Constitute an Anti-Ragging committee with a faculty Convenor and other members of faculty and students headed by Principal to monitor the various aspects related to the menace of Ragging.
- Students and parents are supposed to fill an affidavit at time of admission taking an oath that their ward will not indulge in any type of ragging activity in the college campus.
- Any conduct by any student whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any student.
- Student or Students Indulge in rowdy or undisciplined activities. which causes or likely to cause annoyance, hardship, physical or psychological harm or apprehension thereof in any other student.
- Asking any Students to do any act which such students will not in the ordinary course do or which has the effect of causing or generating a sense of shame or torment or embarrassment adversely affect the physique or psyche of such student.
- Any act by senior student that prevents, disrupts or disturb the student.
- Any act of financial extortion or forceful expenditure burden put on student by other students.
- Any act of physical abused including all variants of it: sexual abuse, lewd acts, gestures, causing bodily or any other danger to health.

- Any act or abuse by spoken words, emails, post public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to any other student.
- Any act that affects the mental health and self- confidence of any other student with or without an intent to derive a sadistic pleasure or showing off power or authority by a student over any other student.

Faculty render assistance to students, an anti-ragging committee consisting of various members of the college actively and vigilantly all the time inspect places of potential ragging make recommendations to the convenor of Anti – Ragging Committee.

A student found guilty by the committee will attract one or more of the following punishments as imposed by Anti-ragging Committee:-

- Suspension from attending classes and academic privileges.
- Debarring from appearing in any test/ examination
- Withholding results
- Suspension and expulsion from the hostel and mess
- Cancellation of admission in serious cases.

The Anti-ragging Committee of the institute shall take appropriate decision including imposition of punishment, depending on the facts and circumstances of each incident of ragging and nature and gravity of the incident of ragging.

An appeal against any of the orders of punishments enumerated herein above shall be to the Principal of the Institute. Her decision will be final in the matter.
